- (2) The Institution agrees to use DETHERM and/or CHEMSAFE data solely for:
 - a) Teaching purposes
 - Research projects completely financed by the government/state.
- (3) For use of DETHERM and/or CHEMSAFE data within the scope of (2) the institution is given the special rate of
 - 50 % of the prices of the actual pricelist
- (4) The special rate in (3) applies until a transaction volume of 2500 € per quarter is reached. For each download exceeding this limit the full list price applies.

- (7) The use of the data as described in (1) and (2) shall be limited to the electronic storage and retrieval of the data on a personal computer, and to reports and research papers where the DETHERM and/or CHEMSAFE data is incidental to the content of the paper or report.
- (8) Information extracted from these databases, except as previously specified, may not be transferred, retransmitted, duplicated, resold, incorporated into a database or offered in any manner to third parties without the written consent of DECHEMA.
